## **Grant Application Guidelines: Organizations**

Funds are also available to local groups for projects that benefit the youth of our community.

MC Chamber Charities is more likely to award discretionary grants to organizations that demonstrate that their proposed projects:

Make a clear difference in the quality of life of the youth of Brunswick;

Promote volunteer involvement;

Demonstrate tangible solutions to community problems;

Involve other funding partner/s, rather than relying on MC Chamber Charities as the sole funder;

Promote collaboration among nonprofit organization/s in the community

Are a sustainable project that continues after the grant funding ends.

Generally discretionary grants are **not** awarded to:

Any organization not exempt under IRS 501 (c) 3 guidelines

Ongoing operating expenses of existing institutions

Annual fund raising drives

Community services which are primarily supported by tax dollars

Endowments

Religious organizations for religious purposes

Individuals other than for college scholarships

Political issues

Travel grants

If your program or project meets the guidelines of MC Chamber Charities, as described above, you are encouraged to submit your application. ## What Happens after the Application is submitted?

After a proposal has been received, MC Chamber Charities will contact the organization's Program Coordinator, as listed on the organization's grant application.

Final decisions on all grant applications are made by the Board of Trustees approximately 6-8 weeks following the grant deadline.

MC Chamber Charities will notify the organization of the Board's decision. A grant contract is sent to the grantee that includes a final report form. Both Chamber Charities President and the organization CEO sign the contract, one copy of which is returned to Chamber Charities.

Grant checks can then be issued as long as there are not special conditions that must first be met by the grantee.

## **Scholarship Application Guidelines**

MC Chamber Charities scholarships are available to:

High school seniors who live in the Brunswick City School area;

Public school, home school, or private school students;

Students pursuing a secondary education degree in an accredited institution.

Scholarships are awarded at the discretion of MC Chamber Charities.

Scholarship applications are available online through the MC Chamber Charities link on the Medina County Chamber Alliance website, www.nmccalliance.com.
